Will be starting 1270 feet South of HWY 37 on Peach Avenue and going South on Peach Avenue for 420 feet. Will be connecting both ends to the existing overhead line on the West side of Peach Avenue. Cable will be a minimum of 48 inches deep in Jordan Township (83N) (43W) Section 18. Vote on motion: Ayes: Fox,
