

**ORDINANCE NUMBER 1**  
**MONONA COUNTY READOPTION ORDINANCE**  
**Title: An Ordinance Readopting the Existing County Code**

Be it enacted by the Board of Supervisors of Monona County, Iowa:

SECTION 1. Purpose: Code of Iowa Section 331.302, subsection ten, requires that once every 5 years a County shall compile its Code of Ordinances. This ordinance readopts ordinances already in effect.

SECTION 2. Readoption of Current Code: The following ordinances have been previously adopted and enacted into law and were duly published as the law provides.
