The Monona County Board of Supervisors met in regular session at 8:30 a.m. o'clock on Tuesday, November 29, 2022, in the boardroom of the courthouse in Onawa, Monona County, Iowa, with Chairman Fox presiding. Other, Supervisors present: Tom Brouillette and Vince Phillips. Supervisor Absent: None. Also, present was Auditor Peggy A. Rolph.

Motion was made by Supervisor Phillips, seconded by Supervisor Fox to approve the agenda. Vote on motion: All Ayes. Motion carried.

Present for the Covid-19 Burgess Public Health update was Patrick Prorok, EMA Director. Adam Hadden of Burgess Public Health was unavailable for an update. Patrick updated the Board that Monona County is in a low transmission rate and RSV numbers are up. Discussion followed with no action taken.

Jim Wigton, IT Director, was present for quotes for a new server. Jim reviewed the two quotes he received from Scantron and High Plains. Discussion followed.

To ensure Monona County remains eligible for state and federal allocation of FEMA funding, the Emergency Management Agency is seeking a commitment from the County to participate in the update of the Plan, to provide a local match for plan development not expected to exceed \$7,000, and to come to a formal agreement with the project host.
