The Monona County Board of Supervisors met in regular session at 8:30 a.m. o'clock on Tuesday, January 17, 2023 in the boardroom of the courthouse in Onawa, Monona County, Iowa with Chairman Fox presiding. Other, Supervisors present: Tom Brouillette and Vince Phillips. Supervisor Absent: None. Also, present was Auditor Peggy A. Rolph.

Motion was made by Supervisor Phillips, seconded by Supervisor Brouillette to approve the agenda. Vote on motion: All Ayes. Motion carried.

Sheriff Pratt was present to inform the Board that he had been approached by the City of Mapleton for the County to take over policing the City of Mapleton. Discussion followed with no action taken.

Secondary Roads Grievance #15765 was discussed, no action was taken.

Secondary Roads Engineer Dustin Wallis was present for Secondary Roads business. Motion was made by Supervisor Fox, seconded by Supervisor Brouillette to approve final acceptance of work agreement form 640003RC-C067(088) Barge Road. Vote on motion: All Ayes. Motion carried.

Discussion items were rock on road for soft spots and survey on Plum Avenue.

Engineer Patrick Mouw presented Preliminary Plans and an Engineer's Estimate of project cost to the Board of Supervisors on the cleanout project for Oliver Lake Lateral "1" with updated figures based on a 3:1 slope along the entire ditch. On September 6, 2022 engineering fees in the amount of \$9,400.00 were approved. Motion was made by Supervisor Brouillette, seconded by Supervisor Phillips to acknowledge receipt of the Sheriff's report of fees collected for December 2022. Vote on motion: All Ayes. Motion carried.

Randy Ping, Temporary Part-Time Custodian did not have an update on the UV lighting.
